Preamble

The Parties state that they have entered into a partnership with the aim to commence the cooperation in order to prepare the project under Priority 3.2. Addressing common security challenges (thematic objective: Security) and to implement it in case of receiving the grant assistance from the ENI CROSS-BORDER COOPERATION PROGRAMME POLAND-BELARUS-UKRAINE 2014-2020 .

Article 1

By signing this Letter of Intent we hereby declare our intention to cooperate within the framework of the above mentioned Program. We agree with the objectives described in The Program.

Article 2

The parties declare that they have legal personality, and thus fulfill conditions for participation in The Program.

Article 3

The letter of intent shall indicate the lead partner and other project partners. The lead partner is Municipality Piątnica /GMINA PIĄTNICA/.

Article 4

In case of a positive grant decision Parties agree

- to mutually cooperate to the best of their knowledge,
- the lead beneficiary is responsible for representing and informing project partners,
- that each beneficiary uses the awarded grant to complete the provisions of the agreement,
- that they are required to attempt to settle disputes by finding a mutually agreed solution.

Article 5

The Parties shall take all necessary legal and factual steps in order to implement the provisions of this letter of intent.

Article 6

This letter of intent constitutes the Parties' declaration of will to commence the cooperation and establish obligation to sign the intended partnership agreement, which is one of the annexes to the application for grant assistance.

Article 7

Each Party bears its own costs accumulated in connection with implementation of this letter of intent, which in particular include expenses for traveling, subsistence costs and others provided for a strong partnership, unless the joint application will receive the grant assistance from the ENI CROSS-BORDER COOPERATION PROGRAMME POLAND-BELARUS-UKRAINE 2014-2020.



Article 8
